

National Instant Criminal Background Check System

The numbers below represent federal and state denial transactions (processed by the FBI and state agencies) from January 1, 2019 through December 31, 2019. This report was generated on June 17, 2020.

The numbers include denials issued by those states that serve as Full/Partial Points of Contact for firearm background checks. The states are required to provide a final status to the NICS on firearm background checks; however, to date, not all states have been able to comply with this requirement.
